

INVESTOR UPDATE

APRIL 2014

Garuda Indonesia 

In April 2014, Garuda Indonesia Group carried 2,068,074 passengers, representing an 8.7% growth year on year, while frequencies were up by 11.4%. The RPK (Revenue Passenger Kilometres) increased 4.5% year on year against 15.4% growth in production capacity (Available Seat Kilometres/ASK). As a result, the group seat load factor decreased by 6.9 percentage points to 65.5%, as growth in traffic still yet to match capacity expansion. We received one aircraft B737-800NG to add up our fleet in April 2014.

DOMESTIC PASSENGER SERVICES

The number of passengers carried on our domestic service increased by 4.1% to 1,247,332 passengers. Our domestic traffic (RPK) was up 4.6% from previous year, while production capacity (ASK) grew 16.3%. This has sent our domestic seat load factor down by 7.7 percentage points to 68.7% as growth in traffic lagged by increasing capacity.

INTERNATIONAL PASSENGER SERVICES

We carried 303,286 passengers on international service, or 0.3% higher than that of corresponding period last year. Production capacity (ASK) recorded a 16.9% growth, while international traffic (RPK) decreased by 1.4% from previous year. As a result, international SLF decreased by 11.3 percentage points to 61%.

CITILINK

Citilink maintained significant performance in number of passengers, traffic, and capacity during April 2014. The number of passengers carried was 517,456, representing a 28.5% growth year on year. The capacity (ASK) increased by 8.5% against 26.8% growth in traffic (RPK). Consequently, the load factor rose to 72.5% or 10.5 percentage points higher than that of previous year.
